# VAT in France



Standard Tax Rate: 20%	all the goods and service
Reduced Tax Rate: 10%	Museum ticket, zoo ticket, cinema ticket, rent for furnished accomodation
Reduced Tax Rate: 5.5%	food, gas, electricity, books
Reduced Tax Rate: 2.1%	medicine, TV licence

## Different rates for DOM

- Standar tax rate : 8,5 %
- Reduced tax rate : 2,10 %
- Particular tax rate : 1,75 % and 1,05 %

## Different rates for Corse

- Standart tax rate : 20%
- Reduced tax rate : 13% and 10%
- Particular tax rate : 2,10% and 0,90%





22% - ordinary rate	unnecessary consumer goods
10% - reduced rate	tourism sector products and services, on electricity and gas supplies for homes, on the purchase of medicines
4%- reduced rate	basic necessities, therefore agri-food and food items in general
0% - reduce rate	preschools and kindergartens, physical and psychological care institutions etc..

## VAT in Italy

- 0% --> they have a strong cultural, beneficial or social value for the place where they are inserted, or that they are aimed at segments of the population protected and deserving of an efficient and low-cost service

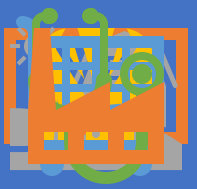
- Young population (46.3% of population age 20 or below)
- Specializes in eco-responsible agriculture and new technology (Transport)
- Government emphasizes on ecological and environment friendly policies
- Tax rates:
  - Hypertax
  - 25%
  - 10%
  - 5.5%



# Tax exemption in ESSCALAND

- Not subject to VAT and other taxation:
  - Transactions that could lead to double taxation
  - Used goods
  - Basic goods related to the medical/pharmaceutical/healthcare field
    - Condoms, diapers, contraception pills, baby's clothes, toilet paper
    - This goods are free on ESSCALAND
  - Goods related to basic general education
  - Money conversion
  - Intra-community trades
  - All export activities

## Goods subject to Super Tax

Tabacco	Fuel	Alcohol
Tax rate = 100%	Tax rate = 110% <ul style="list-style-type: none"><li>• ESSCALAND creates its own biodegradable diesel</li><li>• Fuel is still in circulation but highly expensive</li></ul>	Tax rate = 60% <ul style="list-style-type: none"><li>• Over 15% alcohol per volume<ul style="list-style-type: none"><li>• Ex: Spirits, Pernod, Bacardi</li></ul></li></ul>
