- €20 billion yearly to boost employment
- Unemployment near 10% at that time

Goals and Limits

- Aim : reduce labor costs, create jobs
- Mixed results : some jobs, but high cost

THE PAST THREE DECADES

HISTORICAL OVERVIEW

1995 peak

=> External shocks & internal rigidities

Political reaction:

- Tax increase & spending cuts
- Little structural changes

Results:

Slow decrease in the 2000's due to EU's global economic growth & structure.

2013 peak

=> 2008 crisis impacts, EU instability, labor market issues

Political reaction:

- CICE (François HOLLANDE)
 - €20B annual tax cuts
 - Create 500,000 jobs by 2017

Results:

- ~ 150,000jobs created/ preserved
- Increased business liquidities

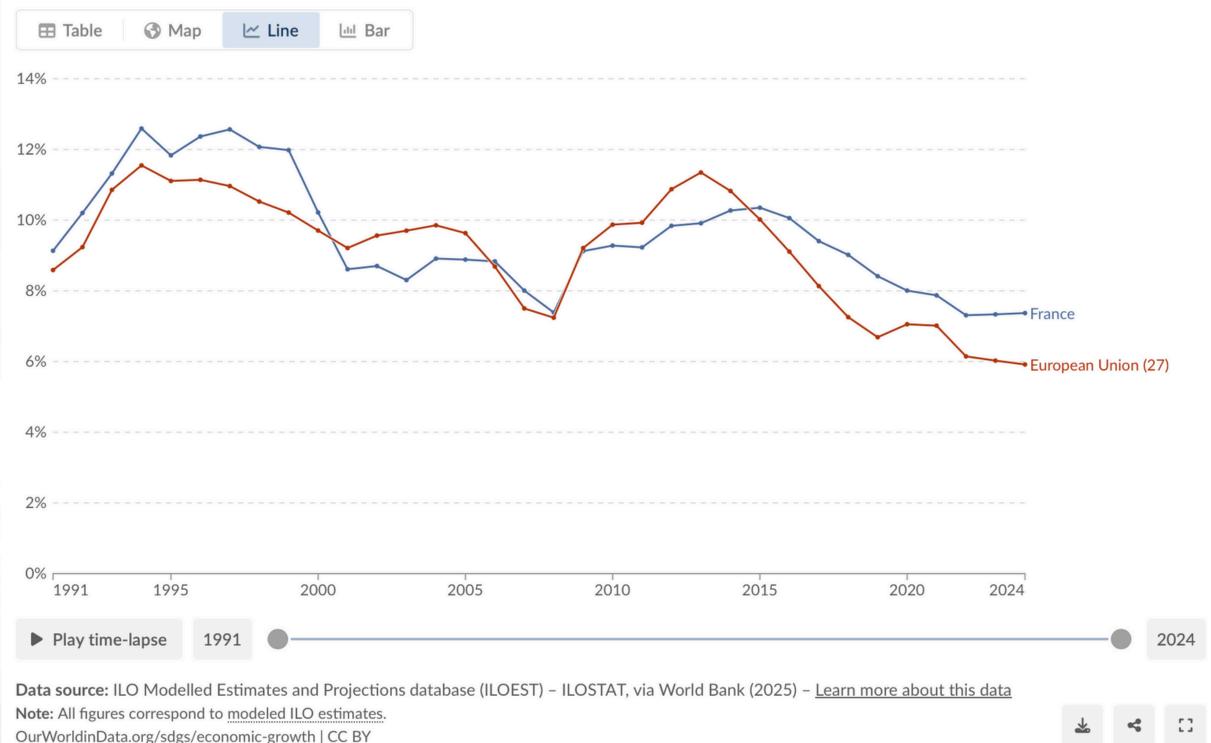
BUT:

Results slow to materialize

Critized to have benefited larger firms over small ones

Unemployment rate, 1991 to 2024

Share of the <u>labor force</u> without work, but actively looking for a job and available to start soon.



CICE CRITICISM HISTORICAL OVERVIEW

Year	CAC40 Cumulative dividends payout	Variation compare to 2013 level
2013	~€37.49 billion	
2014	~€46 billion	+22,67%
2015	~€56 billion	+49,33% / + €18.5 billion

A possible correlated result of the CICE

=> Tax cuts used to benefit shareholders over employees conditions

Observations:

- Substantial cumulative dividend payout increase from 2013 to 2015

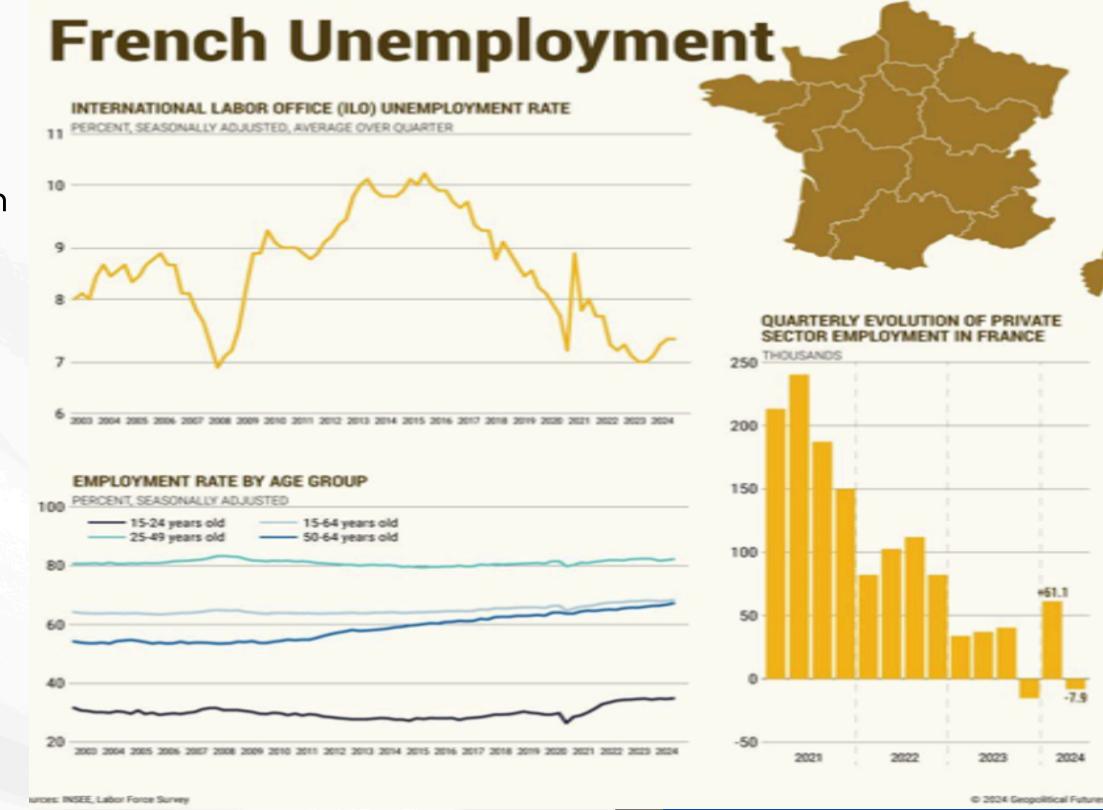
Current unemployment levels

in France

- Before the CICE, in 2012, unemployment in France was around 10%.
- During the CICE, in 2017, it slightly decreased to 9.5%.
- After Macron's reforms, in 2025, the unemployment rate is approximately 7.5%.

So, unemployment has gradually decreased, which is positive.

But many economists agree that this decline cannot be fully explained by the CICE or by Macron's policies alone.

CICE: good first approach twoards less unemployment but has proven innefficient.

The transition from CICE to réductions de charges patronales has shown better success but what other solutions are there?
