---

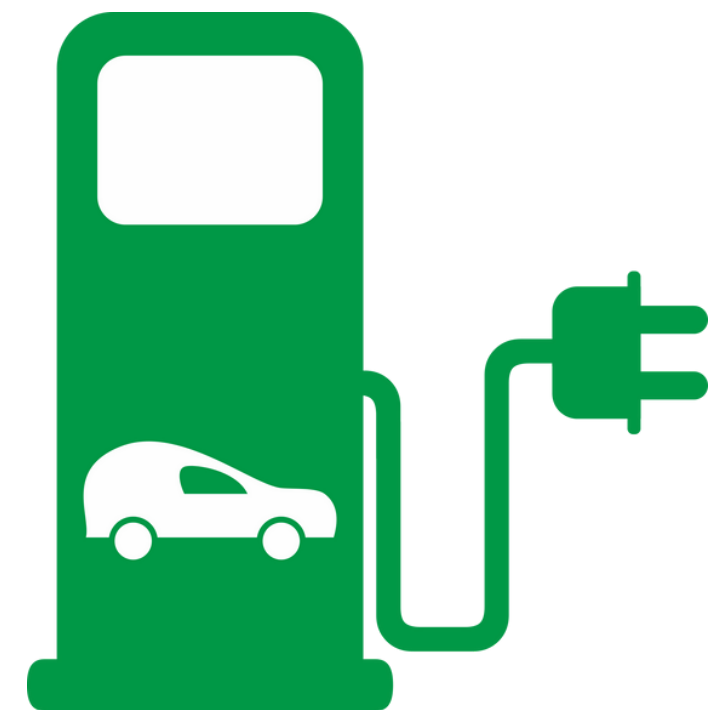
“ Transport helps to maintain free trade between EU Member States and ensures the mobility of people and goods between countries. ”

# Transport in EU and its impact on the environment

---

- Quality of life depends on an **efficient** and **accessible** transportation network.
- Transport contributes to **climate** change, air **pollution** and **noise** pollution.

**1/3 of UE's total final energy**

**1/4 of EU's total greenhouse gas emissions**

# Current legislation in place in the EU for environmentally-friendly transport

---

**Strategy** → decarbonizing transport

→ Transition to **net zero greenhouse gas emissions** in the EU  
by 2050

→ The EEA shows the **evolution of CO2 emissions**

→ The **European ecotax** applies the polluter-pays principle

# The future of EU transportation

---

← **Key objectives** →

Shifting to the **least polluting** and **most efficient** modes of transport

**Transport prices** fully reflect adverse environmental and health impacts

→ 2035: target of **100% reduction of CO2 emissions**, both for cars and vans.

→ Sustainable aviation fuel which represents **only 0.05%** of total fuel consumption in the **aviation sector**

---


→ **Crucial for the maintenance of EU
